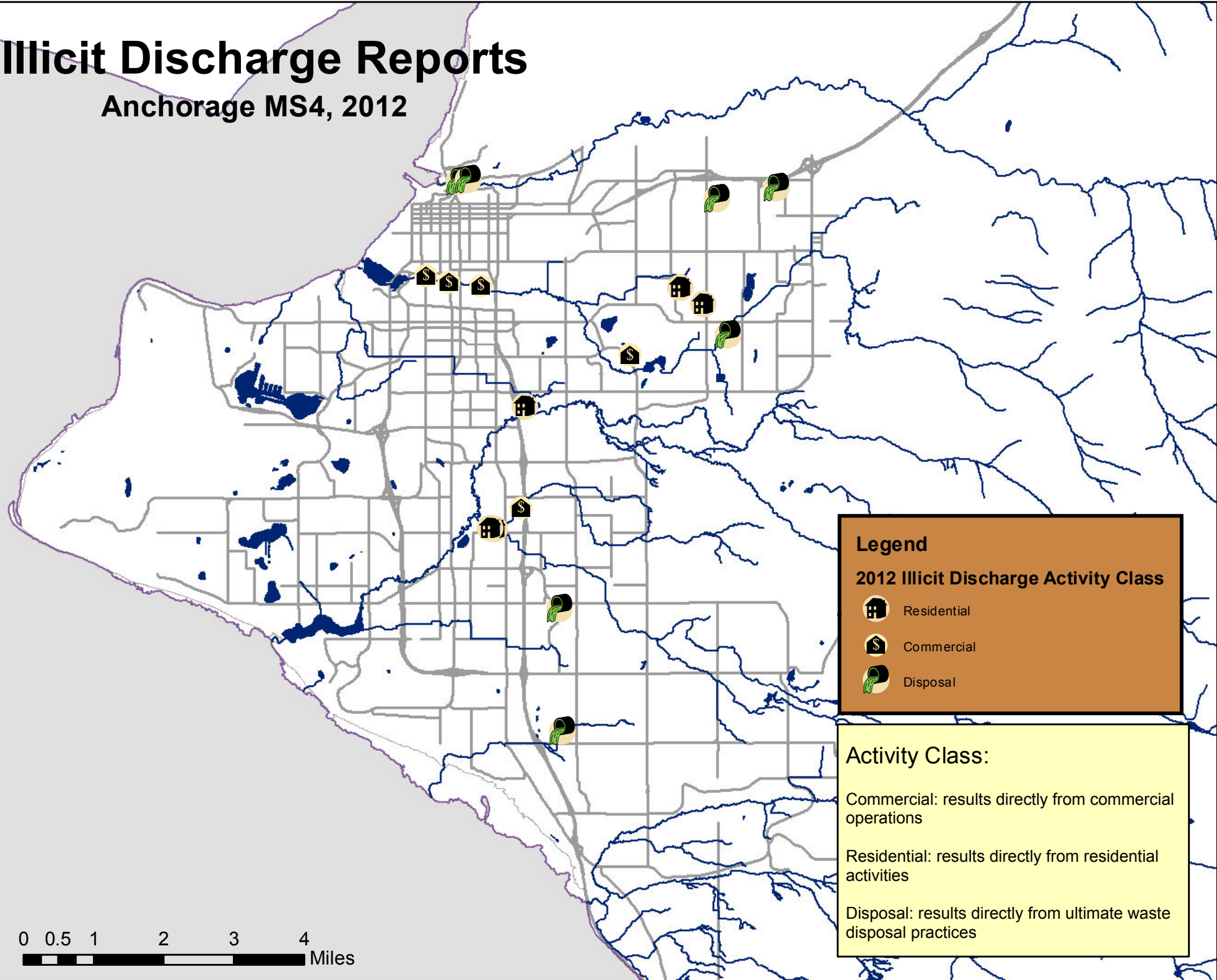


Illicit Discharge Reports

<u>Resolution:</u>
No enforcement possible: Inspector could not prove source of the plowed snow

Education: Violator agreed to cease pushing snow into stream setback
Not substantiated: Caller did not specify what the complaint was
Permitted: Contractor had permit to dewater from construction site
