Eagle River Connect is a pilot project providing accessible curbside transportation connecting Peters Creek, Birchwood, Chugiak and Eagle River to Anchorage. Transportation, provided by AnchorRIDES, is primarily by reservation for curb-to-curb trips to and from desired locations in the Eagle River Connect service area.

Eagle River Connect covers two (2) zones (maps available at www.peoplemover.org):
1. Serving Peters Creek, Birchwood, Chugiak, Eagle River both within the zone and to/from East Anchorage.
2. Serving East Anchorage only going to/from the Eagle River/Chugiak zone.

Travel is available without reservation between the Eagle River Transit Center and the Muldoon Transfer Center in east Anchorage for connections to People Mover routes.
