# Municipality of Anchorage Public Transit Advisory Board Resolution #2022-05

A RESOLUTION OF THE ANCHORAGE PUBLIC TRANSIT ADVISORY BOARD SUPPORTING AMAT'S 2023-2026 TRANSPORTATION IMPROVEMENT PROGRAM AMENDMENT #1.

**WHEREAS,** the Public Transit Advisory Board (Board) was established to advise the Assembly and the Mayor on matters related to public transportation, and

**WHEREAS,** the Board is charged with making recommendations to the Assembly and Mayor on municipal policy with respect to budget review, capital improvement programs, and funding of the publicly owned and operated transit system, and

**WHEREAS,** high-frequency transit routes provide an incentive to housing and commercial development and infill development over the long term, and

**WHEREAS,** the Public Transportation Department (PTD) utilizes local and federal funds for the operation of People Mover, AnchorRIDES, and RideShare services; and

**WHEREAS,** Federal funds, programmed by AMATS, are used to support programs like RideShare, bus stop and facility improvements, capital vehicle purchases, and service expansion; and

WHEREAS, Special consideration and support have been given to the following items in Table 5:

- 1. <u>Seniors and Youth Ride Free</u> Funding to provide free transit trips for people 18 and under and 60 and over,
- 2. <u>Microtransit</u> Funding to help establish an on-demand Microtransit service in Anchorage,
- Muldoon Transit Hub Mixed-Use Development Funding in 2026 to help design and construct a mixed-use transit-oriented development to replace the collection of onstreet bus stops at/near the intersection of Muldoon and Debarr Roads; and

**WHEREAS,** PTD has demonstrated its effectiveness and value to the community through several recent notable achievements, including:

- 1. The award of the Areas of Persistent Poverty Grant in the amount of \$450,000 by the Federal Transit Administration (FTA) to assist in the planning and design of an improved off-street Muldoon Transit Hub,
- 2. Voters' approval of General Obligation Bonds in 2021 to help replace eleven 40-foot People Mover buses that have exceeded their useful life of 15 years or 500,000 miles,

- 3. The award of an ITS grant of \$4.2 million by the FTA to replace People Mover's 20-year-old ITS system to improve system reliability and improved rider tools to be completed by the winter of 2022,
- 4. Implementation of Route 85 that connects downtown, West Anchorage, the Loussac Library, and the Dimond Center,
- 5. The RideShare program has grown to 85 organized carpools with 640 participants, eliminating over 6.2 million vehicles miles on Anchorage roads and highways and reducing CO2 emissions by over 5 million pounds annually; and

**WHEREAS,** PTD maintained service levels despite fluctuating COVID-19 protocols and driver shortages that crippled other transit systems; and


**NOW THEREFORE BE IT RESOLVED** that the Anchorage Public Transit Advisory Board strongly supports the 2023-2026 Transportation Improvement Program (TIP) Amendment #1, specifically the addition of the three (3) new transit projects in Table 5 and recommends that AMATS not reduce the amount allocated and approve the amendment with the three projects included in order to improve bus and carpool services that thousands of Anchorage residents rely upon to maintain their quality of life.


