The next PTAB meeting will be held on April 14, 2022, 5:30–7:00 p.m.

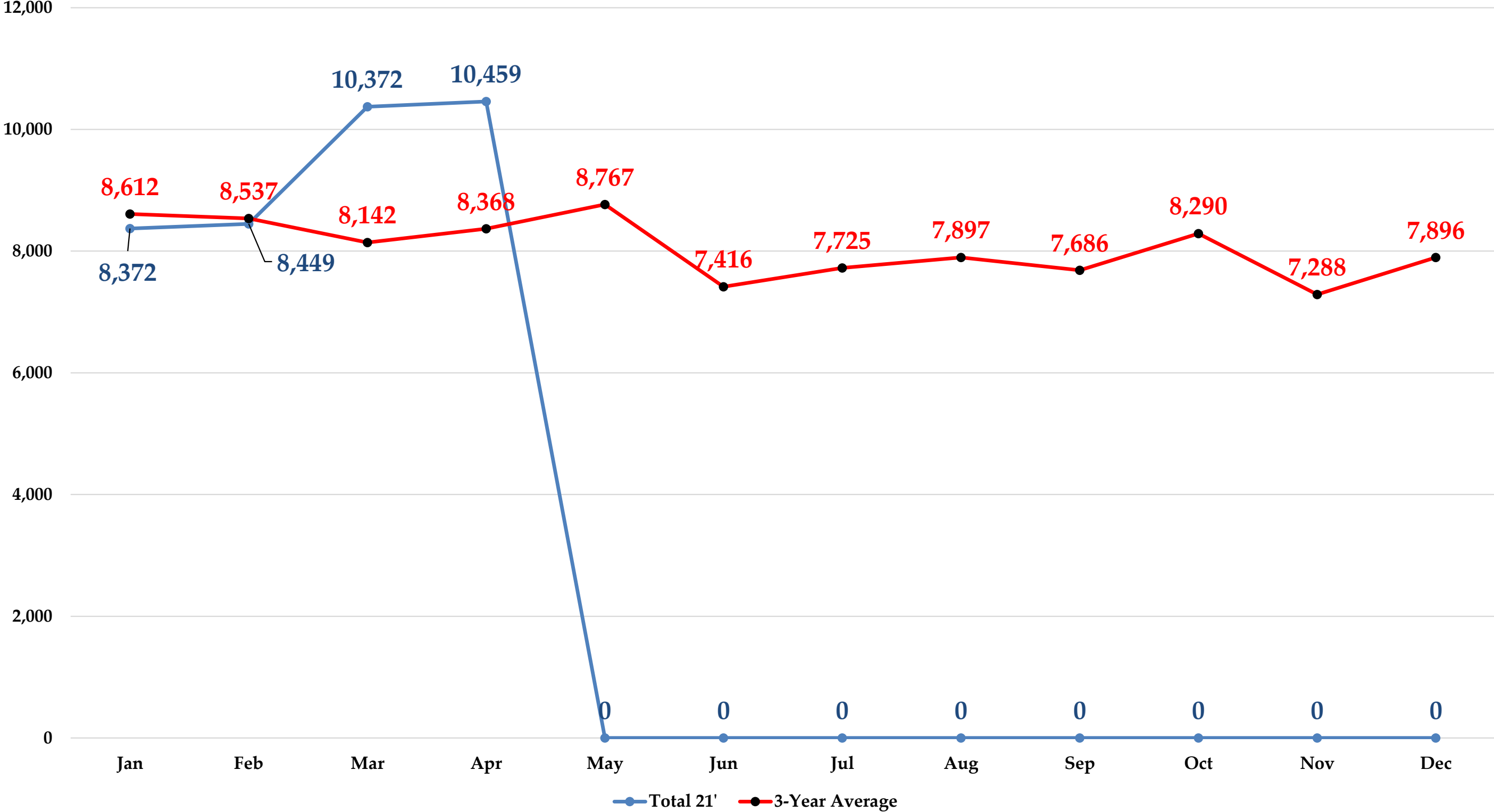

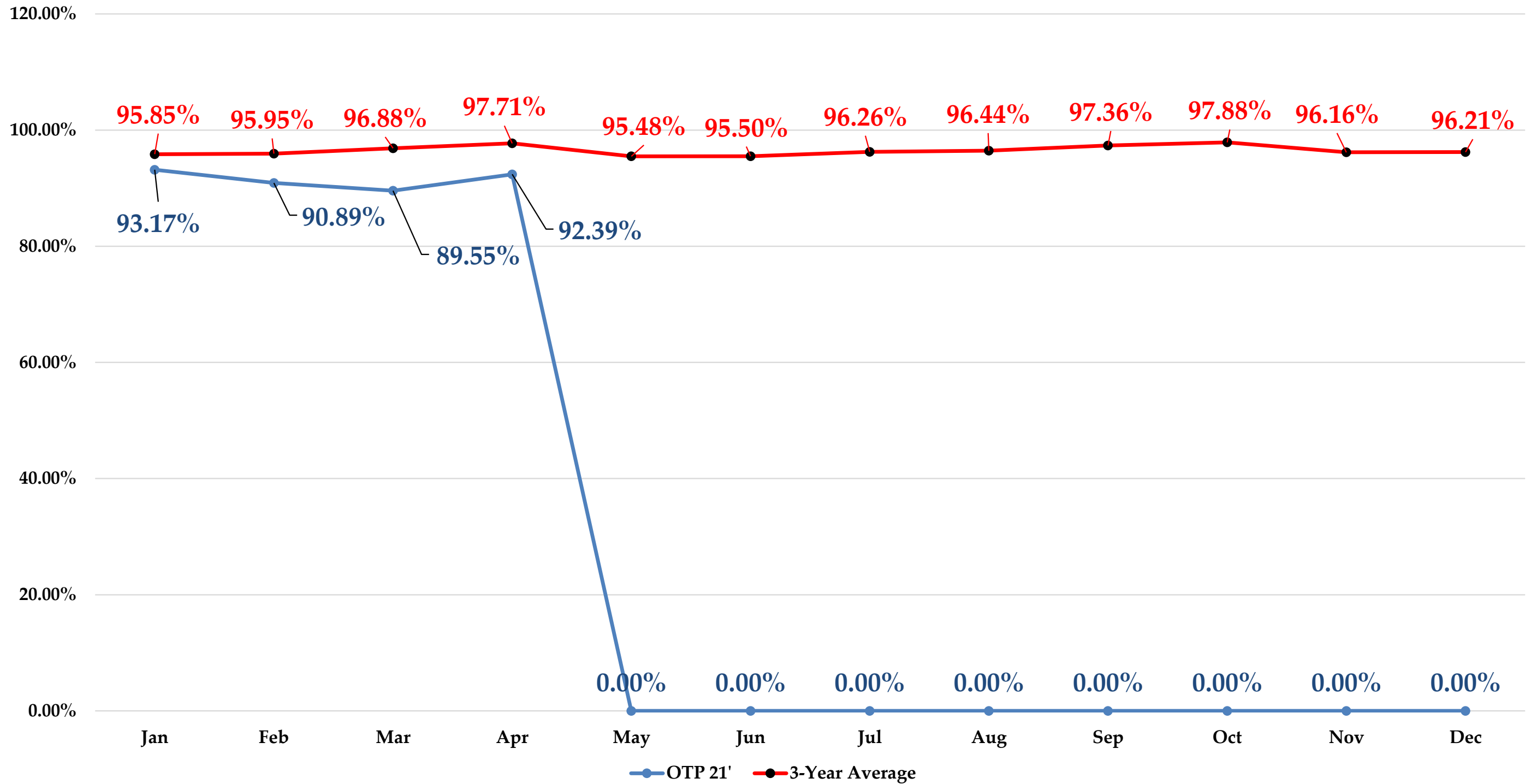

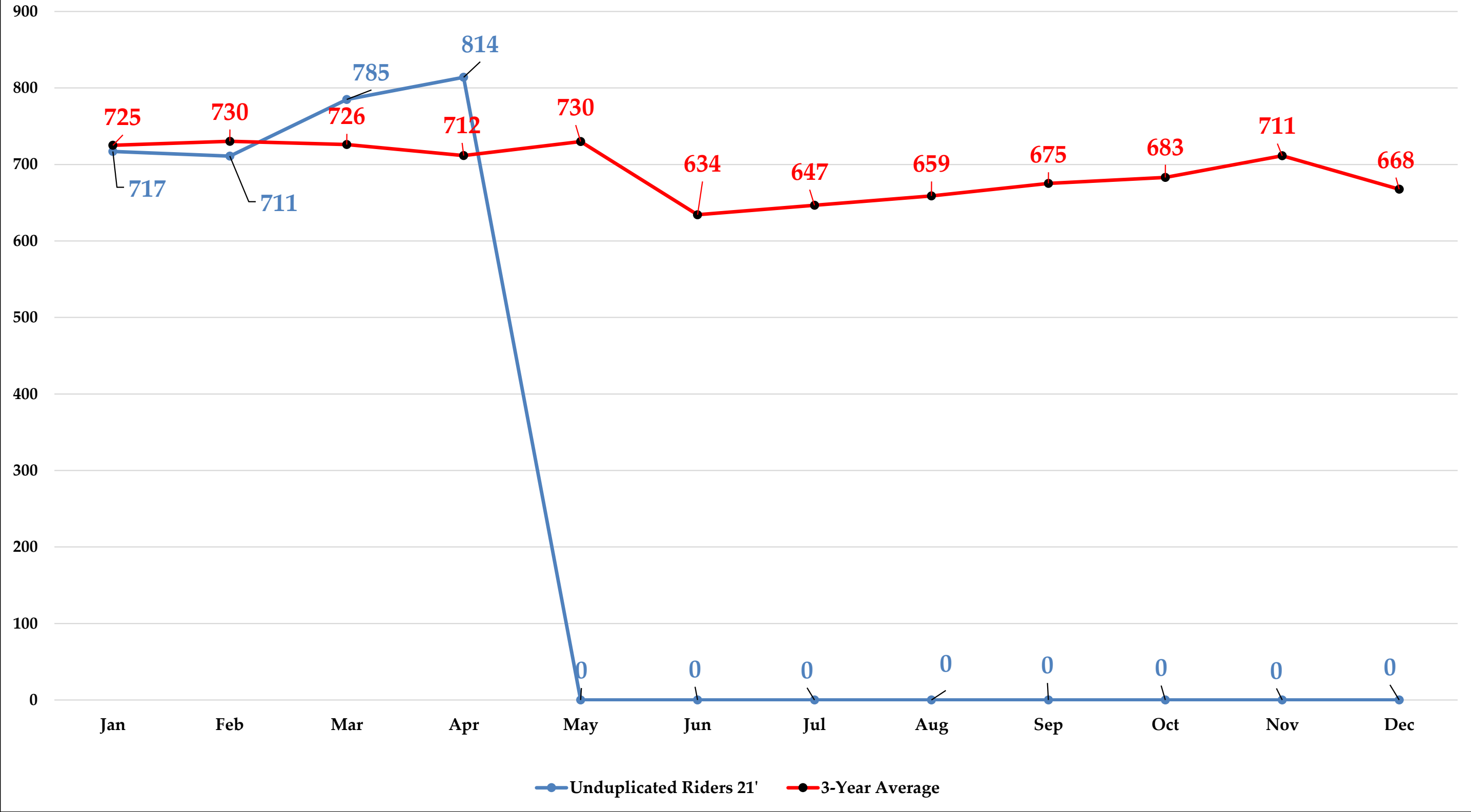
AnchoRIDES 2022 Ridership
