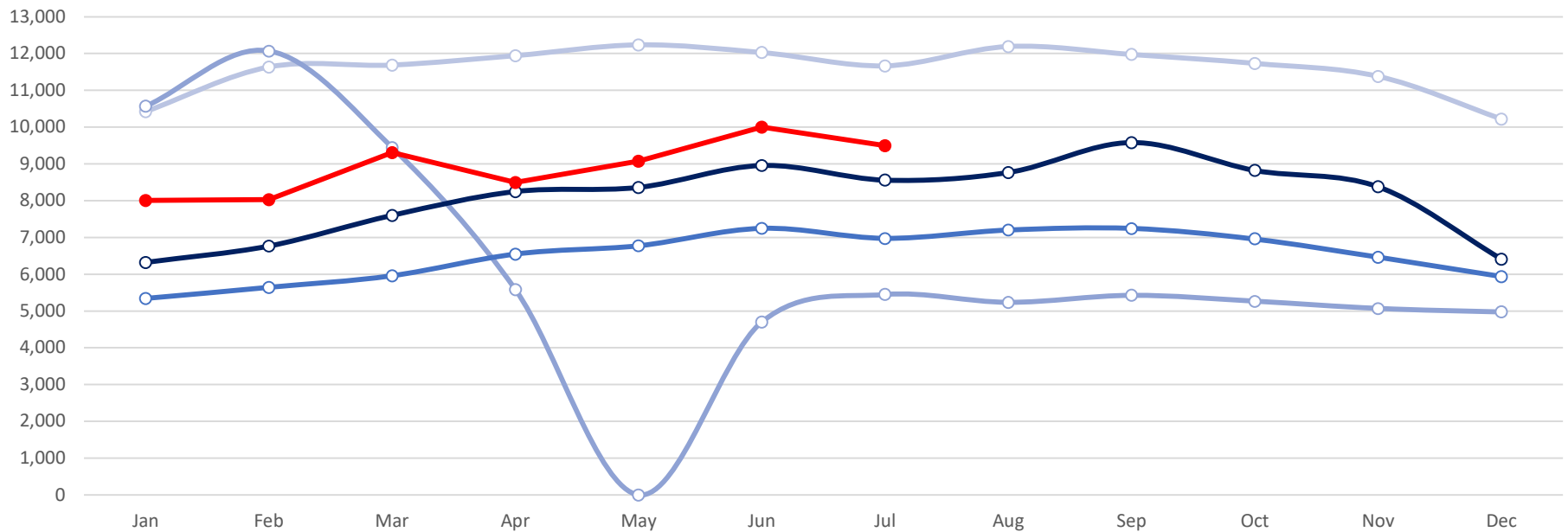

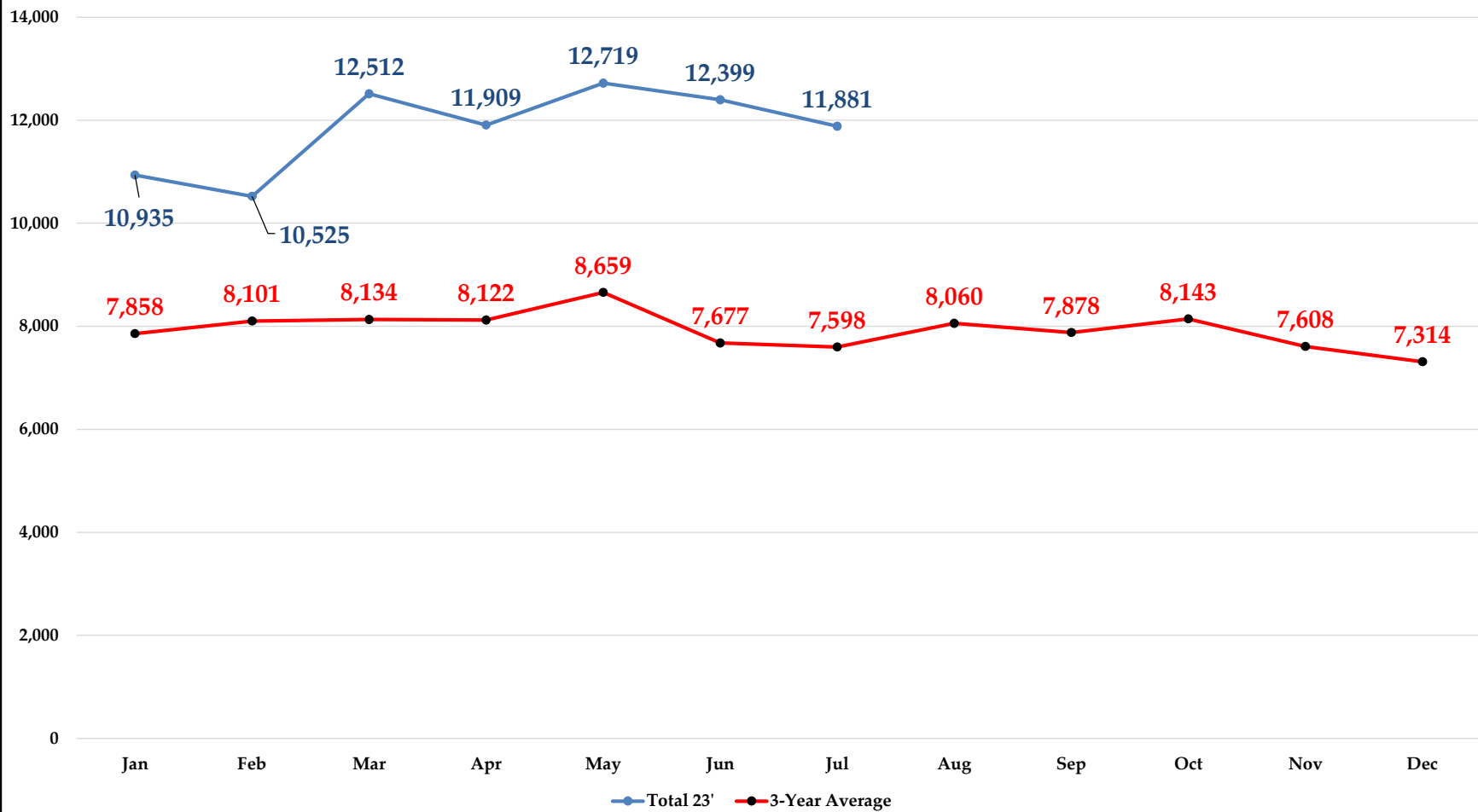

○ 2019 ○ 2020 ○ 2021 ○ 2022 ● 2023

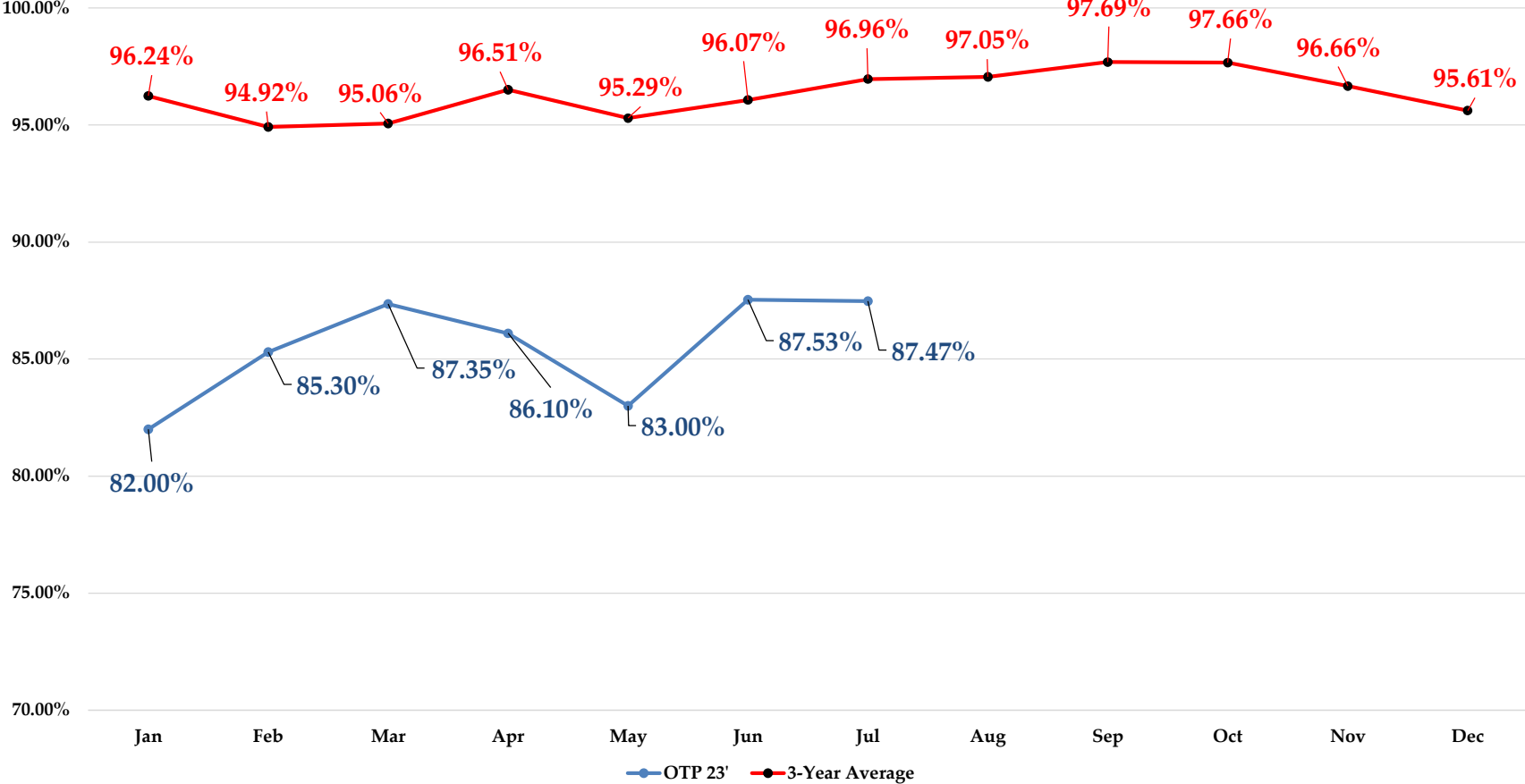


AnchoRIDES 2023 Ridership

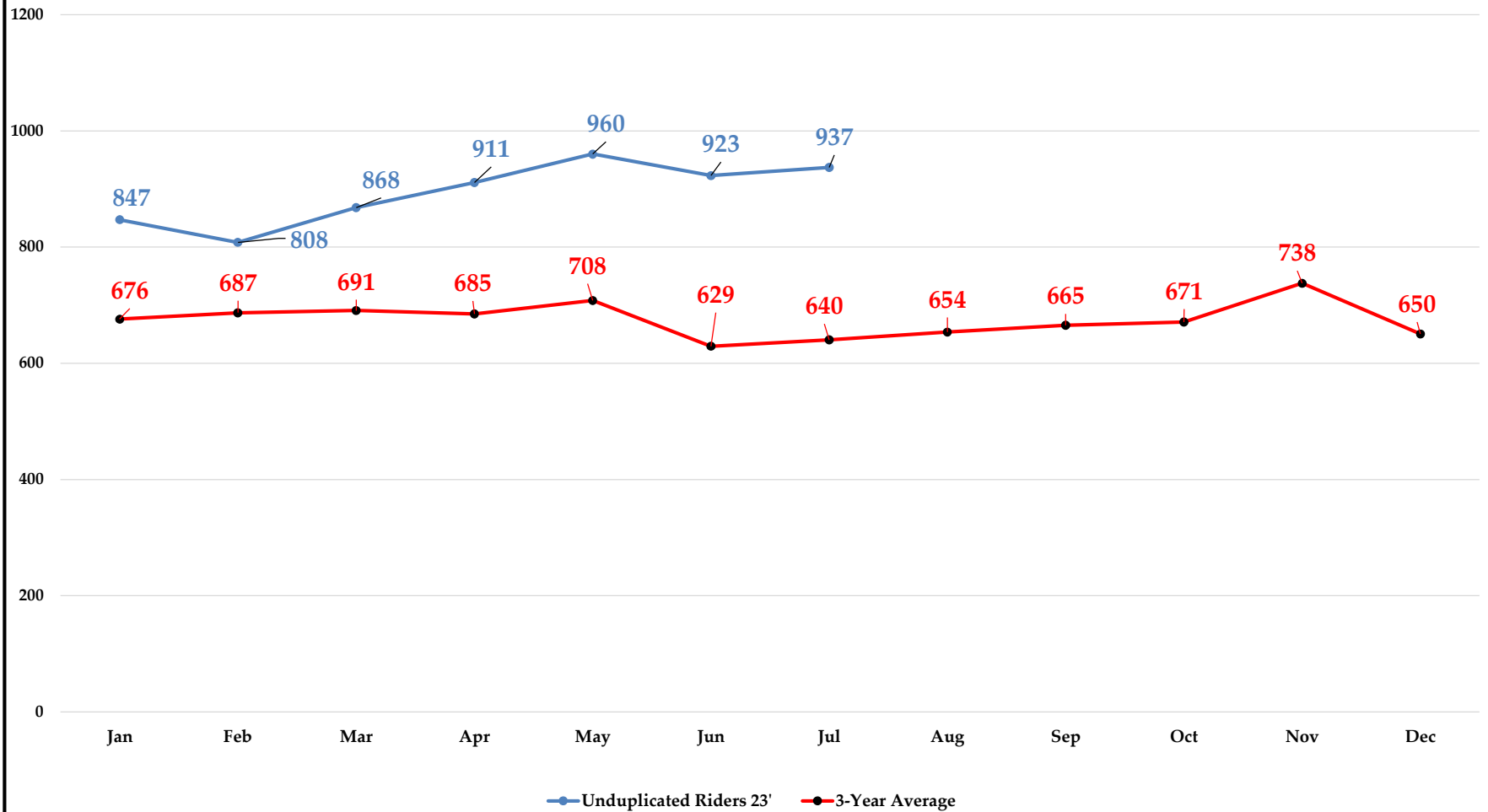


2023 AnchorRIDES On-Time Performance

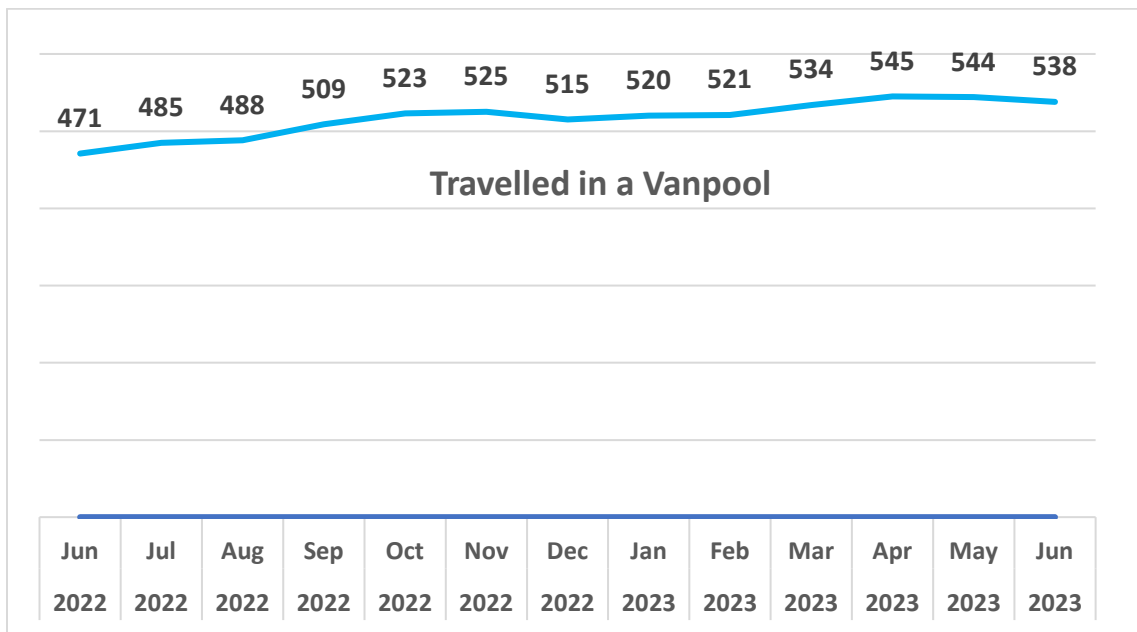
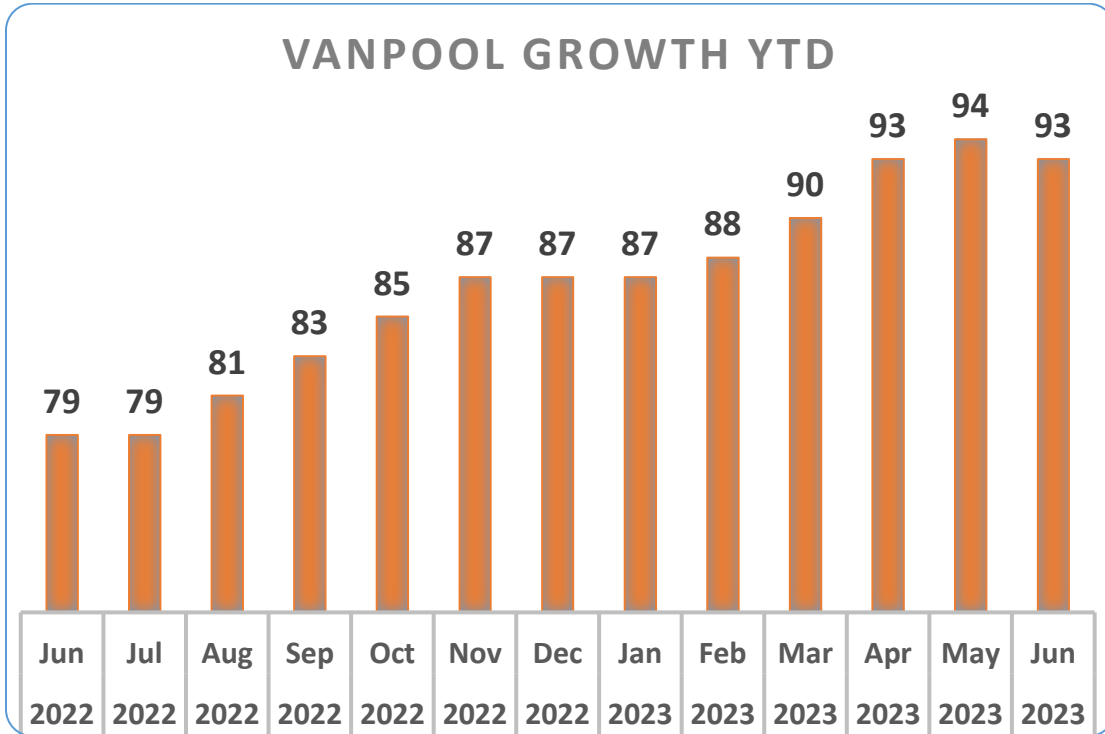

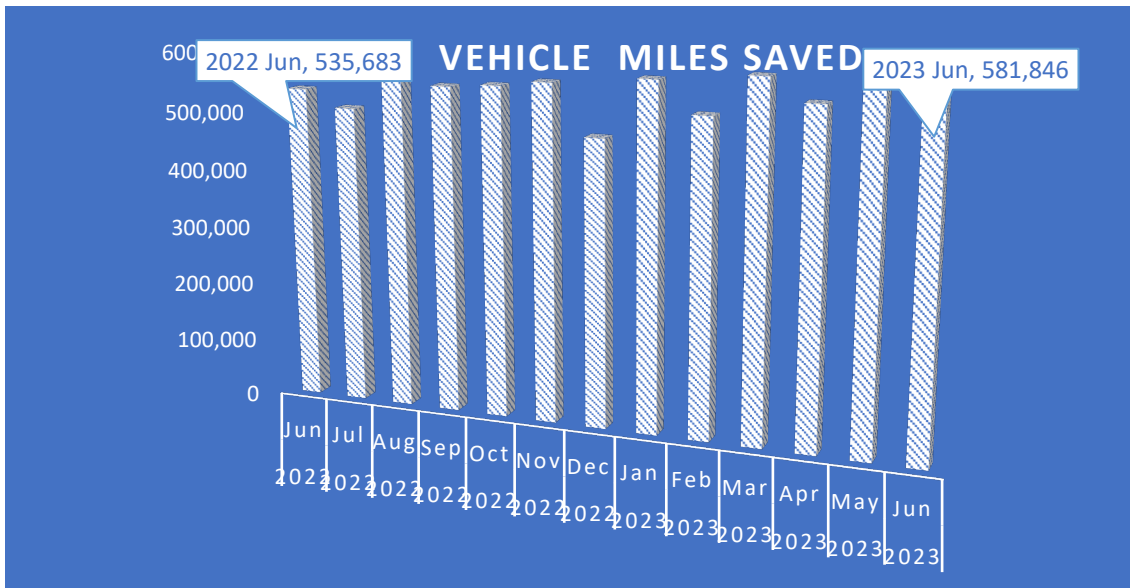


2023 Unduplicated Customers
