The next PTAB meeting will be held January 12, 2022, from 5:30–7:00 p.m.

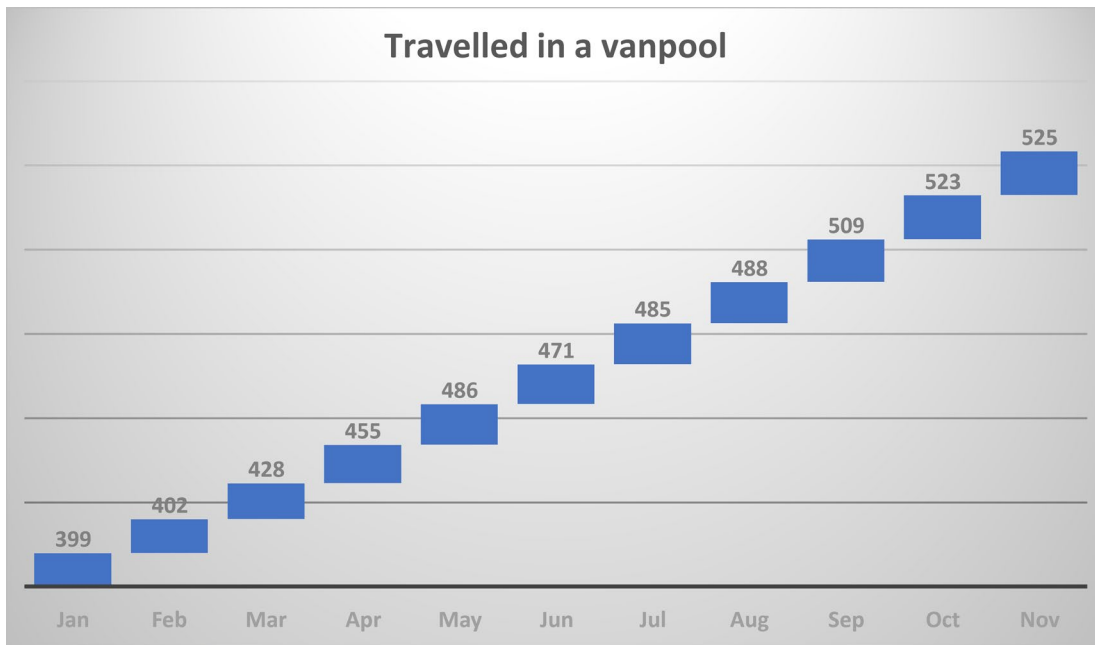
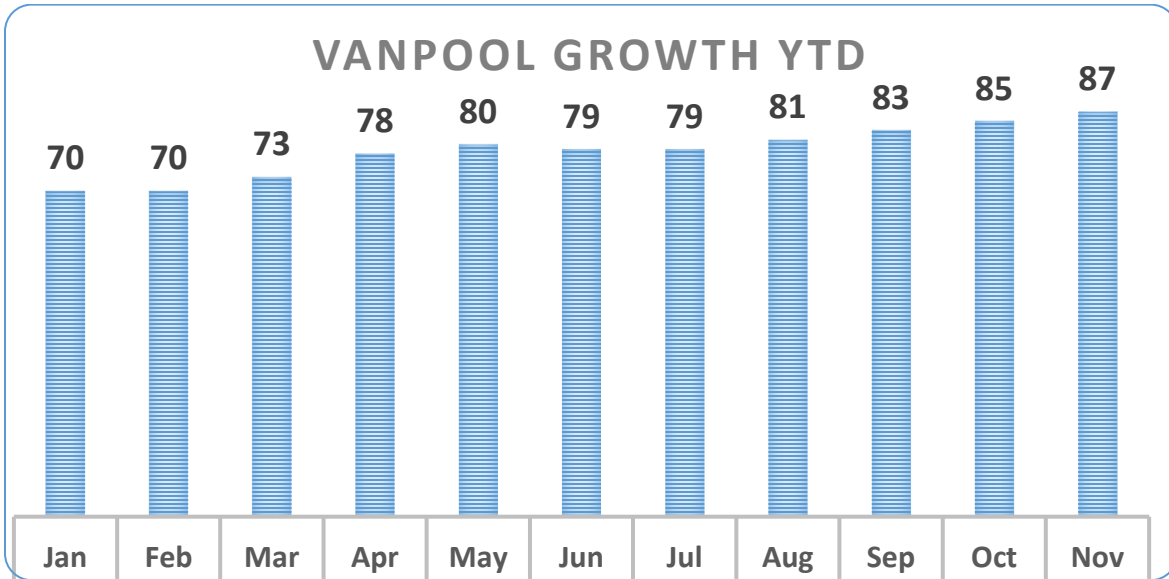

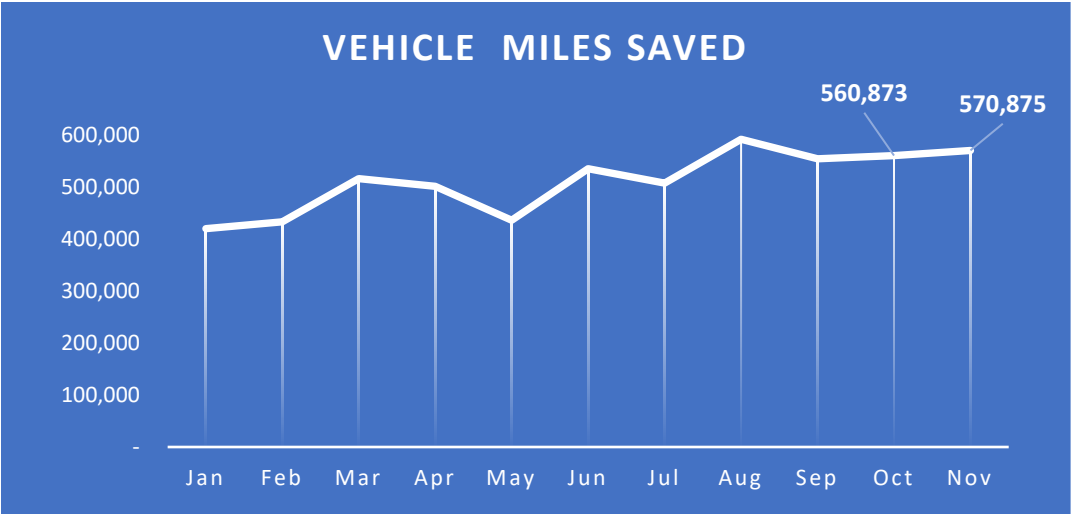
