A RESOLUTION OF THE PUBLIC TRANSIT ADVISORY BOARD (PTAB) RECOGNIZING TRANSIT EMPLOYEE APPRECIATION WEEK.

WHEREAS, public transit is an essential service that provides safe, accessible, and sustainable transportation options for the residents and visitors of Anchorage, supporting economic, social, and environmental goals; and

WHEREAS, the Public Transportation Department (PTD) is responsible for planning, implementing, and operating the public transit system in Anchorage, with the mission of "to connect our community with safe, reliable transportation options, emphasizing customer service while providing economic, social, and environmental benefits;" and
