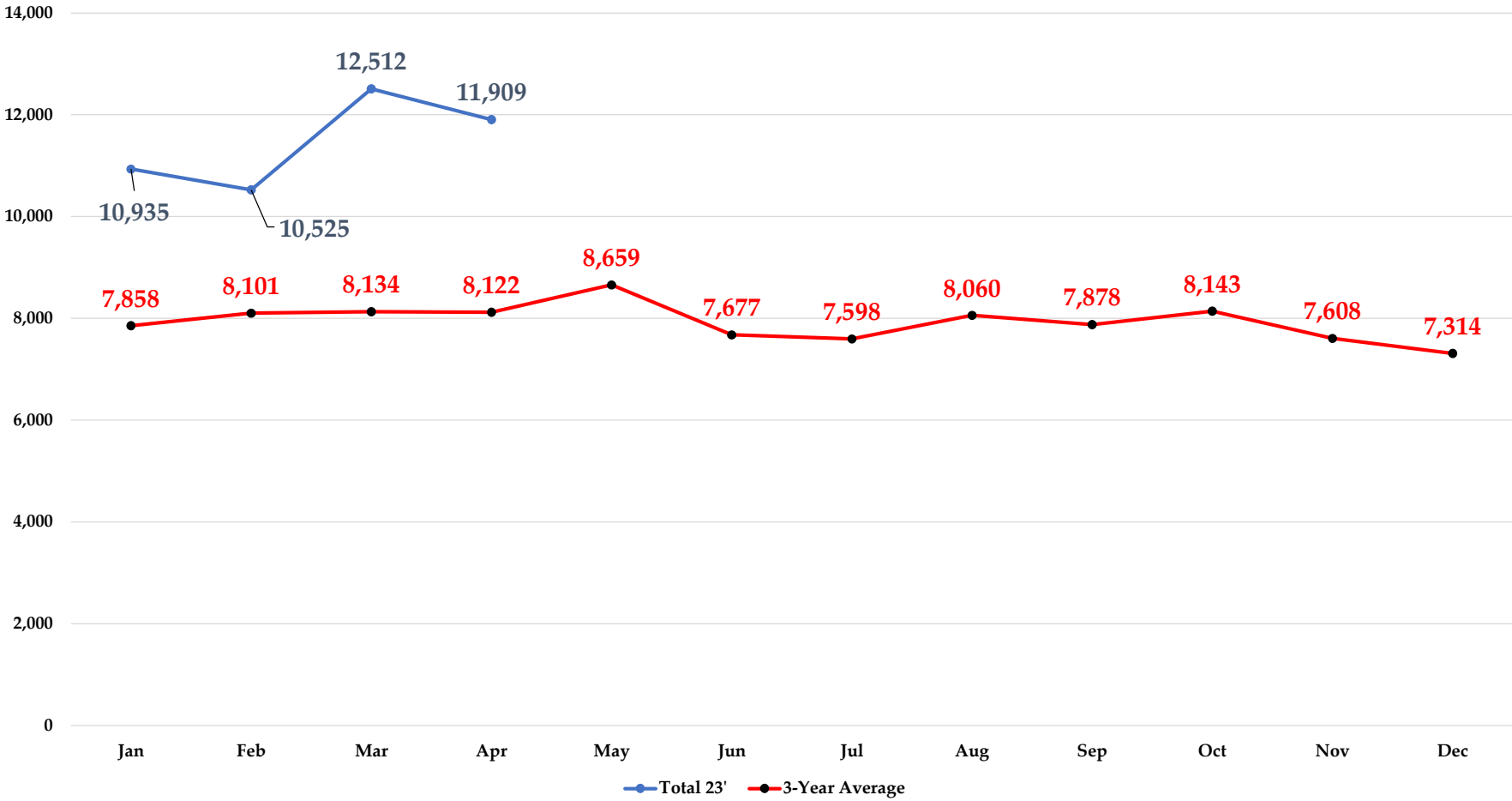

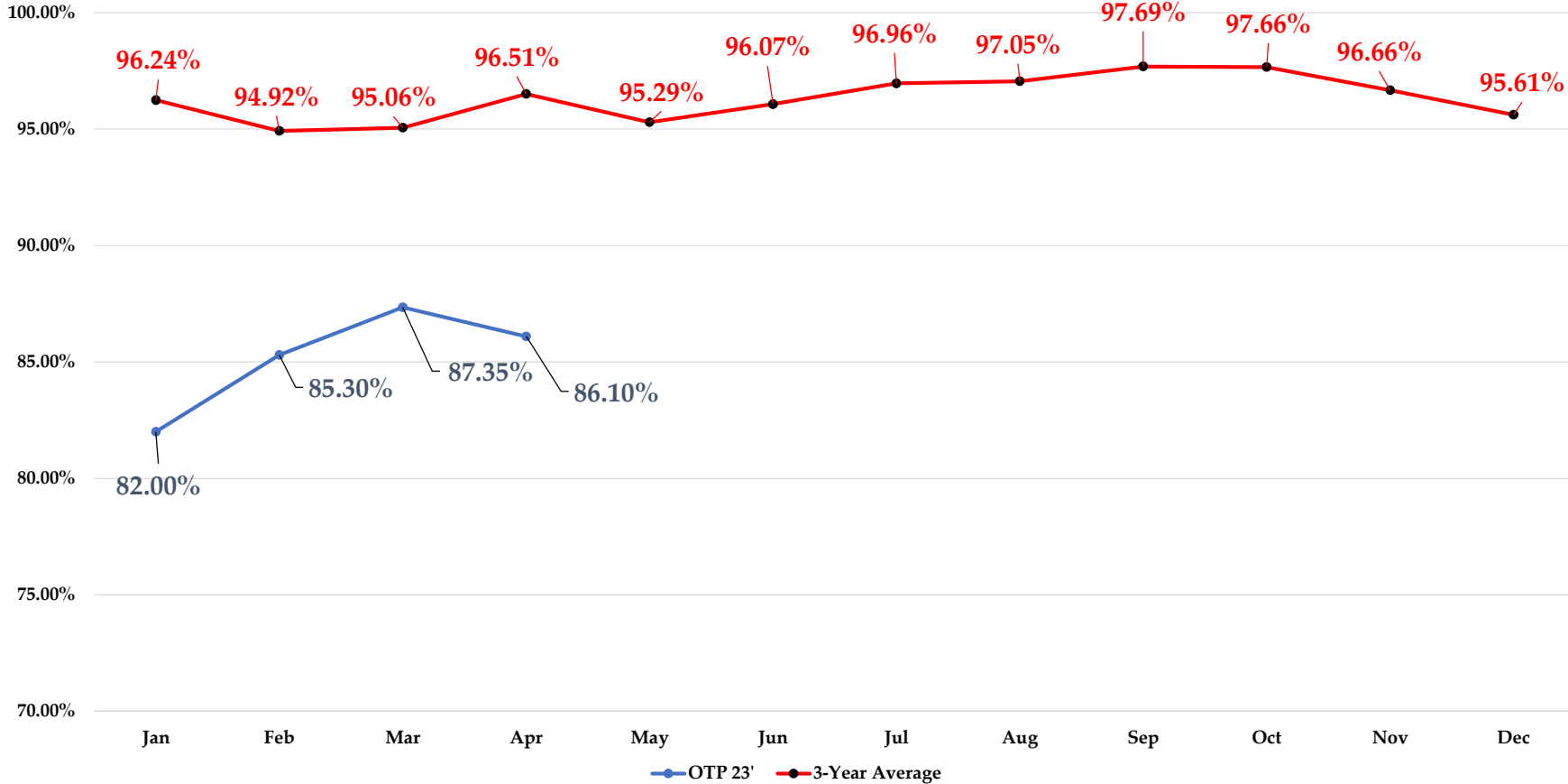


# AnchoRIDES 2023 Ridership

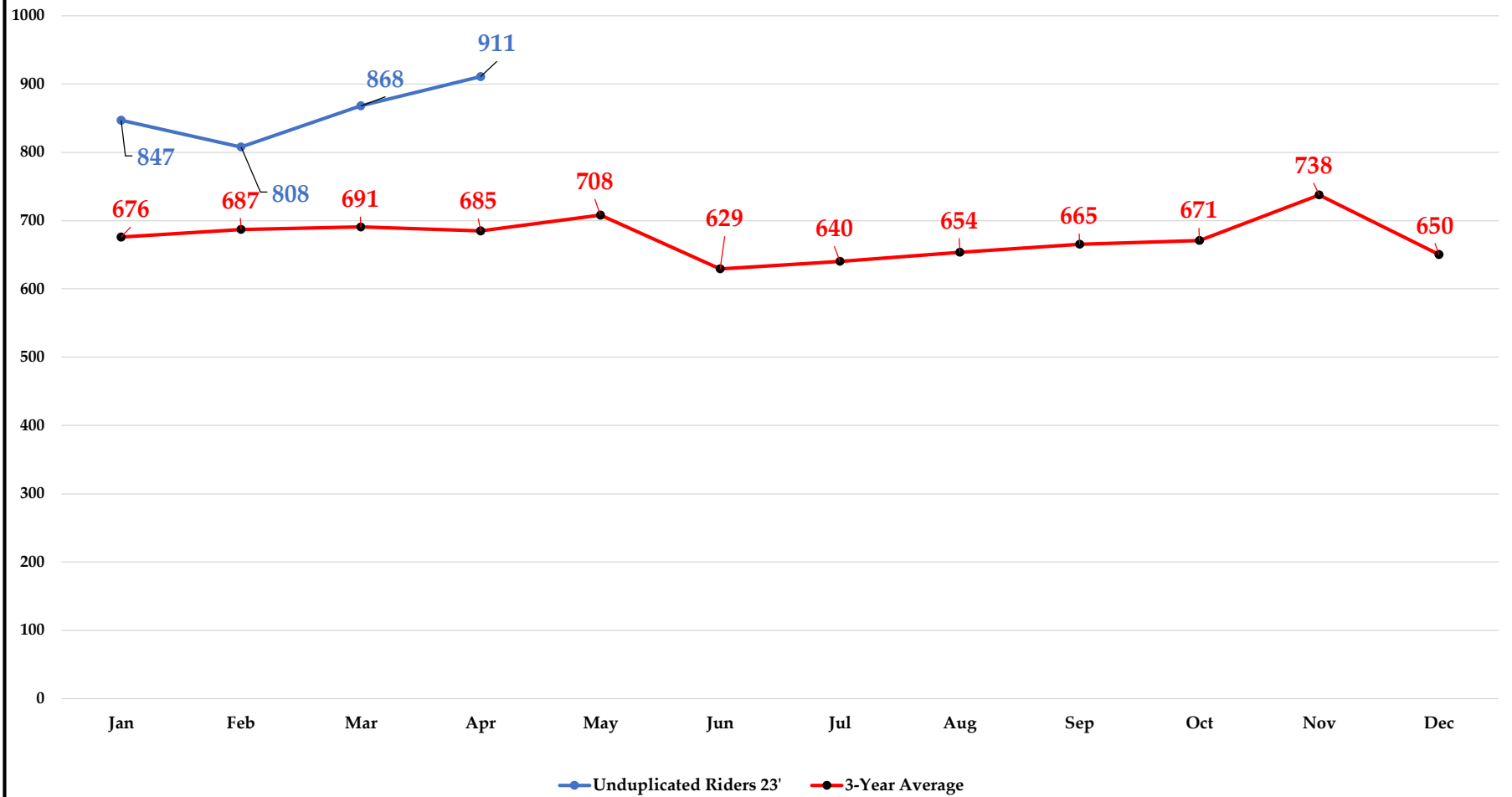


# 2023 AnchorRIDES On-Time Performance

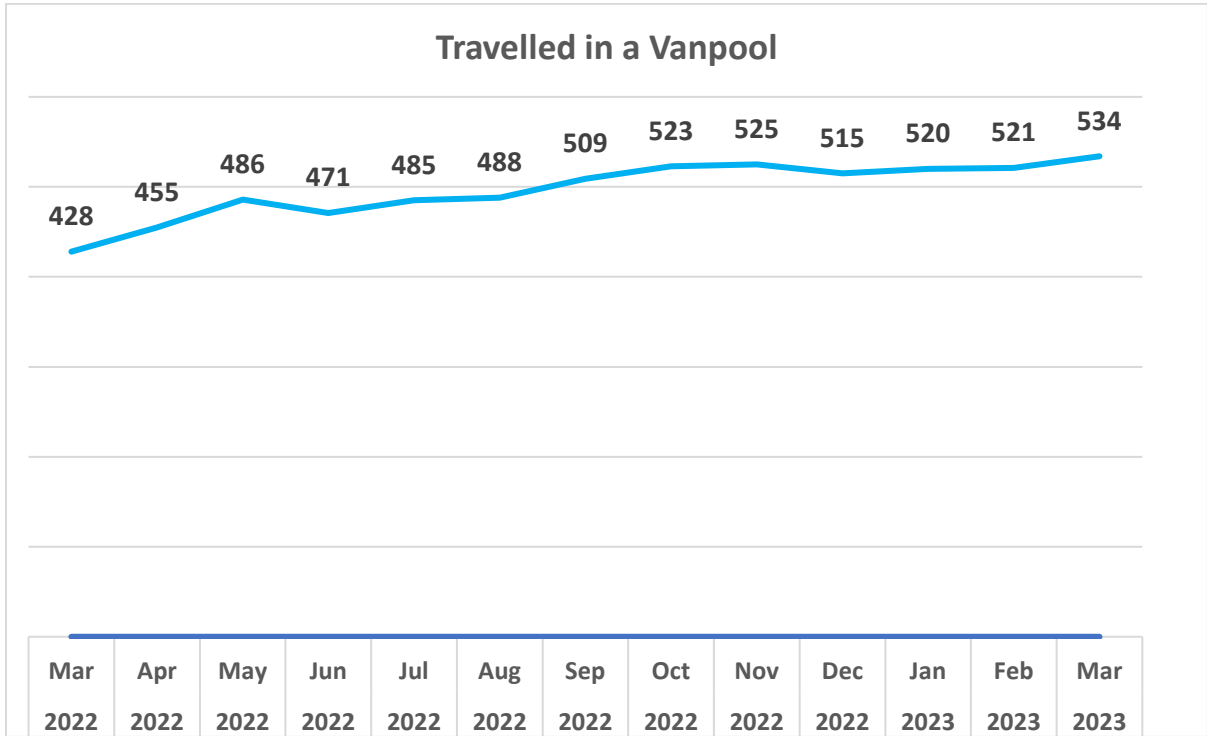
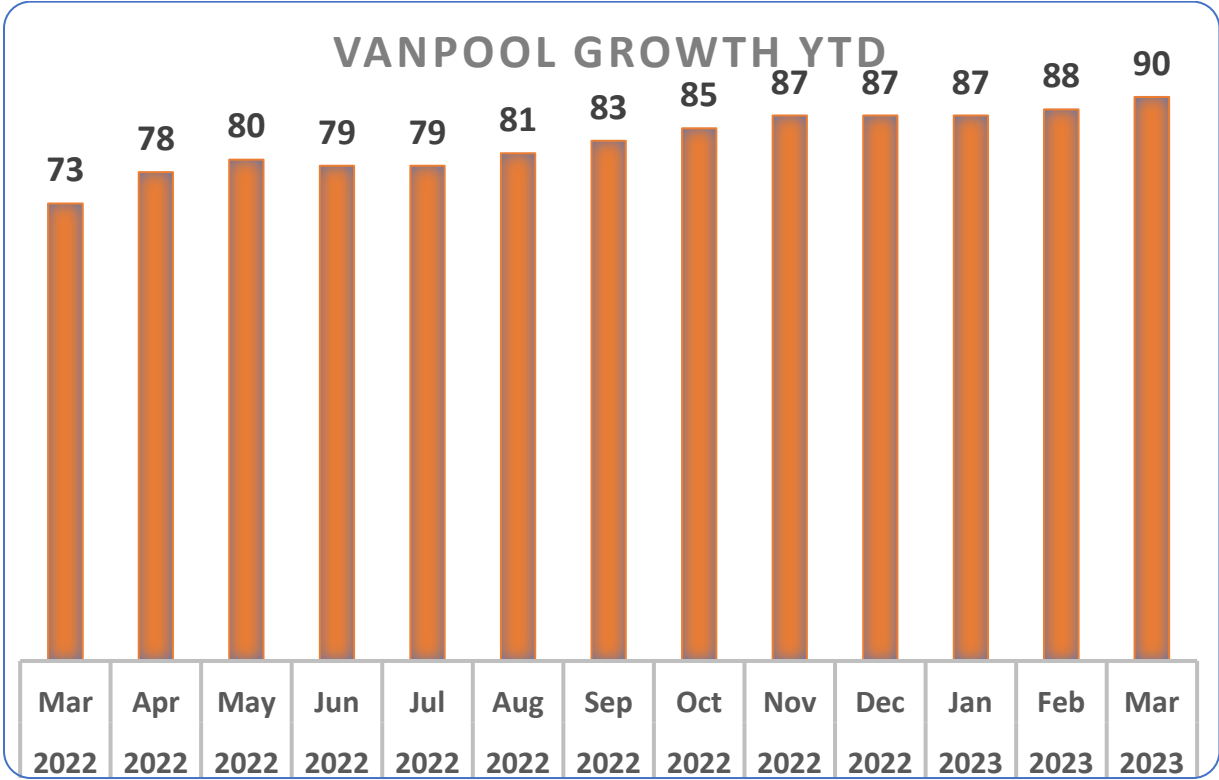


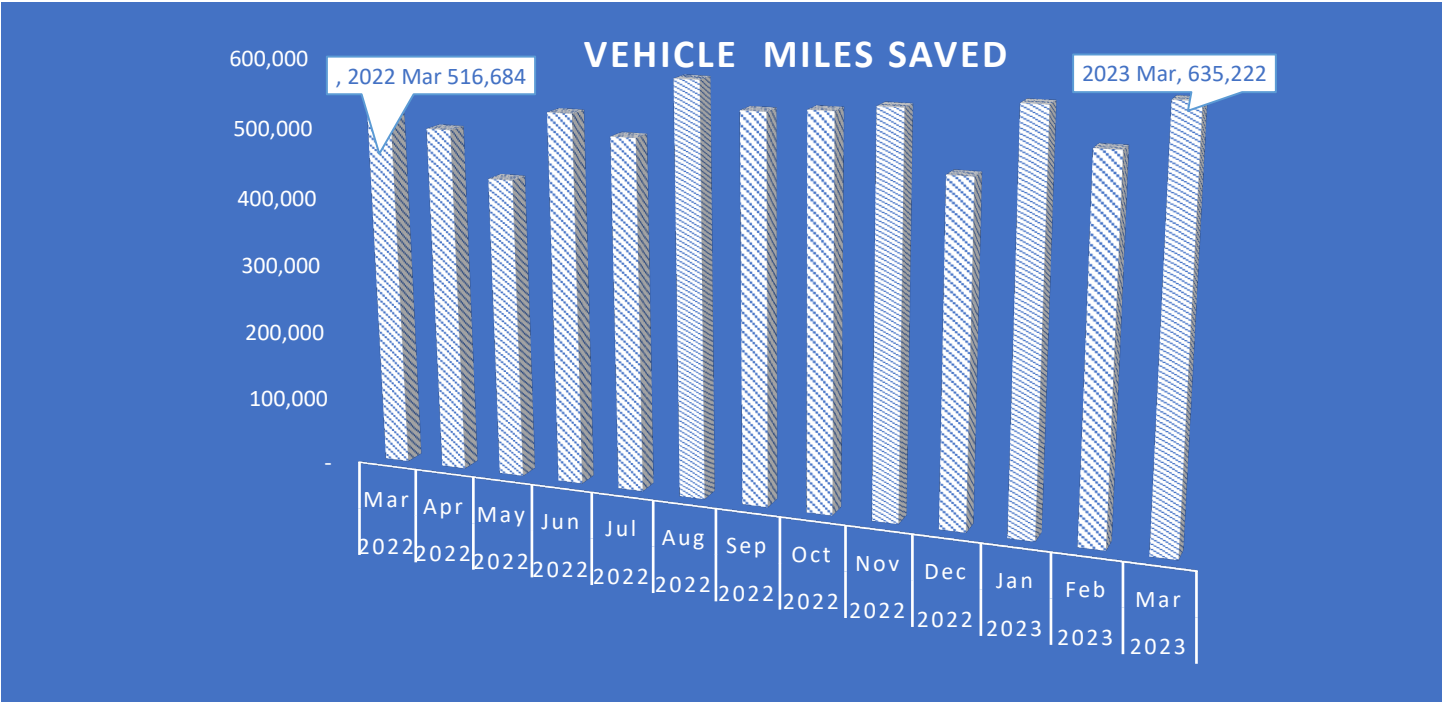
