A RESOLUTION OF THE MUNICIPALITY OF ANCHORAGE REAPPROPRIATING AN AMOUNT OF FORTY THOUSAND DOLLARS (\$40,000) FROM THE CHIEF FISCAL OFFICER TO THE LEGISLATIVE BRANCH FOR THE MUNICIPAL AUDIT CONTRACT, ALL WITHIN THE AREAWIDE GENERAL FUND (101000), 2024 OPERATING BUDGET.

Section 1. That an amount of Forty Thousand Dollars (\$40,000) from the Chief Fiscal Officer is hereby reappropriated to the Legislative Branch all within the Areawide General Fund (101000), 2024 Operating Budget, to be used for the municipal audit contract.

Section 2. This resolution shall be effective immediately upon passage and approval by the Assembly.
