Award of this contract will provide for installation of owner furnished gas-fired boilers and rooftop units. Contractor to furnish and install air conditioning unit, AC-1, new boiler circulation pumps, heating zone pumps, expansion tank, air separator, and provide all work required to replace the damaged heating coil for air conditioning unit, AC-2. Existing roof top unit, RTU-1, airside controls to be demolished and replaced with new direct digital controls. Modifications to the duct, pipe, fittings and appurtenances throughout the building to install new mechanical equipment and re-zone the existing heating and ventilation system.

AS 04.11.420 provides that the board will not issue a license when a local governing body protests an application on the grounds that the applicant's proposed licensed premises are located in a place within the local government where a local zoning ordinance prohibits the alcohol establishment, unless the local government has approved a variance from the local ordinance.





Security for patio

There are always 1-2 servers working the patio who card all customers consuming alcohol. Only way to patio is through the restaurant. No alcohol can leave the premises through the roughly 5 ft. fencing surrounding the patio.

For special events we hire security guards to make sure no alcohol leaves the premises. Patio is only seasonal from May to end of August depending on weather.
