Need: Interest in pedestrian and visual enhancements to this corridor has been expressed and specific improvements identified by the Fairview Community Council and the Fairview Business Association. The Anchorage Assembly has approved the Fairview Neighborhood Plan, which recommends the revitalization of the Gambell Street corridor. Pedestrian facilities in the Gambell Street corridor are hazardous and not compliant with the Americans With Disabilities Act. The flow on Gambell is impeded because of poor road dynamics. Specific improvements have been identified by the Fairview Community Council and Fairview Business Association, funded by the Alaska Legislature. The project is supported by the Anchorage Assembly by resolution.
Project scope: Install pedestrian safety upgrades and transportation improvements. Proposed improvements include reducing Gambell from four lanes to three while undergrounding power lines and widening sidewalks to allow for year-round pedestrian use as well as additional snow storage and plowability.
Project Status: No work is currently scheduled in the 6-year Capital Improvement Program. This is a state-owned facility and evaluation and funding would be through the State of Alaska as well as Municipal and ML\&P funding.

Fairview has three major transportation facilities that could significantly alter the character of the neighborhood. The residents have spoken clearly that development has to match the vision of the neighborhood. This study will be a significant tool to facilitate coordination among the many stakeholders.
Project scope: Fund a transportation corridor study to investigate the impacts of the various mega-transportation projects slated, but not coordinated. Fund a comprehensive transportation corridor study to identify the impacts, proper uses, and other details required to facilitate coordinated development effort.
Project Status: The project has not started. As the roadways involved are state-owned, prioritization and funding would be through the Alaska DOT\&PF. 6

## Eastchester Park Improvement

Cost:

However, the Park needs substantial improvements. $\$ 500,000$ is requested for the long-overdue upgrade. It is the Number! Park Priority for the Fairview Council.
Project scope: Eastchester Park or Woodside Park as some call it, is in desperate need of improvement. It could use paved parking. It warrants a substantial investment as the South Fairview area has numerous high-density developments but almost no recreational facilities. Project elements would include historical kiosks, picnic shelter, play equipment for young teens, consideration of a basketball court, etc.

## Sitka Street Park to Chester Creek

Additional funds required: $\$ 2,200,000$
Need: Neighbors desire a connection to the Chester Creek Trail through Sitka Park. Construction of a trail connection will allow Fairview residents to make a loop circuit of approximately a 40 minute walk. It would add accessible walking and biking opportunities for local youth and visitors to the Anchorage Senior Center. Trail connection was identified as a need during the recent update of the Anchorage Non-Motorized Plan.
Project scope: Funds will be used to design and build a paved multi-use trail connecting to the Chester Creek Greenbelt and Trail.
Project Status: Trail connection nominated for AMATS funding in 2018.

## Fairview Greenway Design and Construction

Need: The Municipal Planning Department noted during their review of the Neighborhood Plan that, on a per capita basis, the residents of Fairview are underserved by convenient access to green space. The Fairview Greenway connection would create, as a practical matter, a pedestrian/bikeway around the urban core of the City and help address many of the concerns identified for the area in the Anchorage Trails Plan. This green beltway would strengthen the linkage between Downtown, South Addition, Government Hill and Fairview and have positive ripple effects for the neighborhoods of North Star, Mountain View, Rogers Park and Airport Heights as they would have ready access to the facility. While there are challenges, they are not insurmountable and the project is worthy of the Municipality's best efforts.
Project scope: Funding is needed for planning, design, right-of-way and construction of a north-south separated bikeway through Fairview. Such infrastructure would connect the Ship Creek and Chester Creek Greenbelts and allow Fairview residents easy access to miles of greenway corridors. To be constructed in conjunction with the H 2 H project. The Scope includes bike overpasses of surface streets and integration with new Parks and green spaces located on the Caps above the Interstate facility.

## SnowFighters Snowblower Equipment

Need: The traditional approach used by the Municipality does a disservice to Fairview residents. The current Snow Management Plan that allows neighborhood sidewalks to be used for snow storage places our heavily pedestrian oriented neighborhood at a serious disadvantage during the six months of winter. A different approach is warranted. Critical pedestrian infrastructure is often unusable for many weeks in the winter. This forces people into cars or causes them to limit their winter outdoor activities. If we truly want to create a more livable Winter, Municipal staff need to be more receptive toward new approaches for improving our collective quality of life.
Project scope: Project will acquire heavy duty snowblowers for use by neighborhood residents as part of an organized neighborhood-based snow removal initiative. Participants will receive safety training and sign liability waivers. Proposal is for Parks and Recreation to drop off snowblowers in October, pick up in April for summer maintenance.

## Forest Health and Park Safety

Cost: \$200,000
Funds on Hand: \$0
Additional funds required: $\$ 200,000$
Need: In September of 2012 more than 5000 trees were lost during a windstorm. Initial assessments estimate clean-up to be over 1 million dollars. The Anchorage Urban Forester's plan to address the damage include a mix of volunteer clean-up, commercial sales and contracted clean-up. Currently, park assets are safe for park and trail users, however as conditions change, follow-up risk assessment and clean-up is required.
Project scope: Funds will be used to conduct a follow-up risk assessment, develop a recommended strategy for species management (cottonwood, evergreen, birch), finalize a tree emergency plan and continue the clearing of hazard trees on parkland from the 2012 windstorm.
Project Status: Park Maintenance and horticulture crews have cleared parks and trails making current park assets safe for Anchorage citizens.
