## 1 Spinnaker Dr Area Drainage Improvements (15-14)

Status: Feb 28 2017 - Design was funded with 2015 road bonds. Scope of work assessment, field investigations and preliminary design currently underway. Attended Huffman/O'Malley Community Council Meeting and presented project.

## 2 Westwind Dr Surface Rehab - Legacy Dr to De Armoun Rd

Status: Feb 28 2017 - This project has not started. State grant funding is proposed to resurface the roads in the Turnagain View Subdivision.

## 3 Lake Otis Pkwy Surface Rehab - Abbott Rd to Huffman Rd

Status: Feb 28 2017 - The project has not started. Bond funding is programmed in the CIP for design.

4 Mulligan Rd Upgrade RID - 135th Ave to De Armoun Rd

Status: Feb 28 2017 - No work is currently scheduled in the 6-year Capital Improvement Program. Funding will be through the Road Improvement District program in which the project is initiated by property owners who agree to pay 70% of the costs through special assessments.

#### 5 Turnagain View Estates Subdivision Trail Lighting - Mainsail Dr to Eastwind Dr

Status: Feb 28 2017 - This project has not started. State grant funding is proposed.

6 Little Campbell Creek Basin Improvements

Status: Feb 28 2017 - The project has not started. Annual state grant funding is proposed.

#### 7 Elmore Rd Extension - Abbott Rd to O'Malley Rd

Status: Feb 28 2017 - No work is underway or scheduled in the six-year Capital Improvement Program. This is a state-owned facility and evaluation and funding would be by the State of Alaska. Improvements will be considered as part of the State's O'Malley Road upgrade project that is in design.

## 5 De Armoun Rd Upgrade Ph II - 140th Ave to Hillside Dr

Status: Feb 28 2017 - Environmental and design work was completed by the State of Alaska. However, the project is being re-evaluated in light of public comment and future funding is uncertain. This is a state owned facility.
