Priority 1

Northeast area-wide pedestrian safety and traffic calming

Agency:

Cost: \$3,000,000.00

Additional Funds Required:

Need: The need for traffic calming especially to address pedestrian safety is the highest priority of the Northeast Community Council. The Council has identified as their priorities the streets around elementary schools, and the roads identified in the scope.

Project Scope: Highest priorities around elementary schools. Projects include Duben Avenue (Grand Lary), 4th Avenue between Boniface & Newell St, Patterson between DeBarr and Sherwood, State St. btw E 20th to E. 16th, Parkway Drive from Muldoon to E. 18th, Augustine Dr., Elmrich subdivision (Trafford Lane, Dickerson Drive, 2nd Ave & Fern St), Staedem Drive, Whisperingwood Park Drive & MacArthur Place, Rebel Ridge & easternmost portion of E. 20th. Muldoon sidewalk safety improvements. Pedestrian accommodations like sidewalks should be considered as well as traffic calming measures where applicable.

Need: Since the completion of the master plan in 2016, P&R has completed Phase 1 of development (along Muldoon Road) and will complete Phase 2 in summer 2022. Currently, Chester Creek separates the two areas and bridges are needed to connect the park.

Project Scope: Chanshtnu Muldoon Park is Anchorage's newest park. Funding will be used to connect developed areas through the park currently separated by Chester Creek by trail and bridges.

Project Status: Phase 1 was completed in 2018. Phase 2 began in 2020 and will wrap up in summer 2022. Additional funds are needed to complete a connection from Phase 1 to Phase 2 which will include two bridges.

Recreation connection from Cheney Lake SW corner along South Fork Chester Creek to Patterson. South-North connection - Muldoon Curve to Glenn Highway trail. Preferred Boundary Trail along gasoline. Route needs to be optimized.

Priority 11

Northeast District Traffic Circulation and Safety Study

Additional Funds Required: \$360,000.00

Need: The East Anchorage District Plan will provide an important review of the transportation circulation and safety need for the area, however the necessary funding to support an in-depth and complete analysis is lacking. This study will support that effort and bring recommendation and priorities.

Project Scope: This effort will focus on the traffic circulation and safety impacts of the new commercial developments at the northeast regional mall and the growing Creekside Town Center. The scope of the transportation circulation and safety study is to focus on the coordination of the future streets in the study area, with particular interest of connectivity between subdivisions, where applicable. The plan will also identify potential traffic related problems that may occur as a result of land use development related to location and density with recommendations to address those concerns. The study scope is expected to focus on the residential street network within neighborhoods. The result is expected to provide better neighborhood internal circulation which could lessen the burden of arterial streets carrying localized traffic needs.

Project Status: No work is underway and no funding is proposed in the six-year Capital Improvement Program. The project will remain on the Capital Projects Needs List for future funding consideration.

Priority 12

Four Seasons Mobile Home Park Area Storm Drain Improvements (19-11)

Cost: \$4,700,000.00

Funds on Hand: \$400,000.00

Additional Funds Required: \$4,300,000.00

Need: According to an investigation by Street Maintenance, the bottom of this 48" pipe is rotting out and the top is pulling down in many spots.

Project Scope: The project will replace the storm drain from Boniface Parkway to the manhole near the intersection of East 4th Avenue and Newell Street.

Project Status: 2019 road bonds funded the design start. On hold pending re-assignment to a new designer.

Priority 13

Forest Health and Park Safety

Agency: Parks and Recreation

Cost: \$200,000.00

Funds on Hand: \$0.00

Additional Funds Required: \$200,000.00

Need: Clean up efforts are still needed for areas of forest impacted by the 2012 windstorm event. Additionally, the recent infestation of spruce bark beetle in southcentral Alaska will result in significant loss of spruce trees and will require mitigation to reduce fire danger and ensure public health and safety. Also, invasive species along greenbelts are impacting native vegetation and riparian/stream health.

Project Scope: Funds will be used to address various issues impacting forest health on parkland. This includes the mitigation of spruce bark beetle kill, the removal of hazard trees from the 2012 windstorm, and the management of invasive species.

Project Status: P&R crews and CARES Act funded contractors completed thousands of hours of work in 2020 to remove beetle-kill spruce along trail corridors and adjacent to develop facilities such as playgrounds and picnic shelters. Park maintenance and horticulture crews continually assess parks and trails and address issues as they come up to ensure that park assets are safe for Anchorage citizens.

Need: Low block walls were installed along Muldoon Road as part of a State of Alaska road project to provide visual cohesiveness along Muldoon. Sections of this wall have been destroyed and additional visual cohesiveness is desired.

Project Scope: Rehabilitation and updating this wall as a cohesive element along Muldoon Road. Include curb stops or other impediments to reduce damage to wall sections.

Russian Jack Springs Park

Additional Funds Required: \$2,150,000.00

Need: RJSP is one of Anchorage's oldest and most well-used parks. Upgrades are needed to rehabilitate aging trails and facilities as well as to develop new community identified facilities.

Project Scope: Implementation of community priorities as identified in the 2022 updated master planning.

Project Status: The department is working to complete an update to the Russian Jack Springs Park master plan with final approval anticipated for spring 2022. Funding will be used to rehabilitate trails, add wayfinding and trail lighting, sledding hill safety improvements, general facility improvements, and parking and access upgrades.

Systemwide Trail Wayfinding

Need: Trail signage and wayfinding is inconsistent throughout Anchorage's park and trail system. Adding signage and wayfinding will help residents and visitors navigate our parks and trails, reduce barriers to access for underserved neighborhoods, and create a safer and more enjoyable experience on Anchorage trails.

Project Scope: Design, development and implementation of wayfinding for Anchorage's paved & soft surface trails.

Project Status: Anchorage has over 250 miles of trails. Implementation of a comprehensive suite of signage and wayfinding throughout the trail system will help address safety concerns as well as improve neighborhood access and navigation to destinations.

Gilmore and Prosperity Estates Subd Area Road Resurfacing (14-52)

Agency: Project Management and Engineering

Cost: \$2,000,000.00

Additional Funds Required: \$1,940,000.00

Need: The roads in these subdivisions to the west of Beaver Place are experiencing frost heaves, cracking, pot holes, and curb jacking. The trail from More Lane to Prosperity Drive has been overgrown with vegetation.

Project Scope: The project will resurface the roadways with digouts where needed to reestablish a solid road base. Replace curb as needed. Remove vegetation and resurface trail from More to Prosperity.

Project Status: Project is on hold until Construction funding becomes available. Design study was funded with a 2014 state grant. Year of Construction will depend on availability of funding. No survey or soils required.

Community Garden Site Selection and Design and Management Standards.

Need: The public demand for plots in MOA Community Gardens far exceeds the current availability. New community gardens have been identified in a number of newly completed park master plans. Funding will be used to develop new community gardens.

Project Scope: Identify appropriate parks in the Anchorage Bowl where community garden development is appropriate. Create design and management guidelines to assist the department in building and maintaining community gardens.

Project Status: The department manages five community gardens with 230 garden plots available for the general public to rent. Locations include the Bragraw Gardens, C Street Gardens, Fairview Gardens, McPhee Gardens, and Chanshtnu Muldoon Park. In 2017, the department collaborated with the University of Alaska Anchorage to survey Anchorage residents and to better understand the need for additional community garden plots in Anchorage. Since then, the department has increased garden plots by 25%, adding two new food forest, expanding existing gardens, adding new amenities, and developing a new garden at Chanshtnu Muldoon Park

Dog Park Site Selection and Design and Management Standards.

Need: Anchorage has an estimated 65,000 dogs. By nature, dogs need safe spaces for exercise and socialization. Designated off-leash areas provide spaces for residents to recreate with their dogs and help to minimize conflicts with other park activities. Additional off-leash areas are needed to serve the community along with design and management standards to ensure that off-leash areas are maintainable and safe.

Project Scope: Identify appropriate parks in the Anchorage Bowl where dog park development is appropriate. Create design and management guidelines to assist the department in building and maintaining dog parks.

Project Status: Currently, Anchorage has designated 9 off-leash dog park areas. Three off which have been added in the past 5 years. Valley of the Moon in 2018, Whisper Faith Kovach In 2019, and Chanshtnu Muldoon Park in fall 2021.

Need: State Street, Greendale Drive, and Northview Drive lack adequate drainage. Residents are experiencing water issues and the surface of the road is deteriorating. The 2020 GASB survey rated these streets in fair and satisfactory condition.

Project Scope: Improvements are expected to include a new road base with fresh pavement, storm drains with curb and gutter, and street lights.

Project Status: The project has not started. Funding will be through the 90/10 ReConstruction Road Improvement District program in which the project is initiated by property owners who agree to pay 10% of the costs through special assessments.

Project Scope: Improvements are expected to include pavement, curbs, pedestrian facilities, street lighting, storm drains, and landscaping. The actual scope will be developed during the design phase which includes public involvement.

Project Status: Draft 95% plans are complete. PTS is assessing property acquisitions (10th & M Seafoods). Additional funding needed. Muldoon intersection work will be completed with this project.

Need: In 2012, P&R worked with the northeast community to complete a campground improvement plan. The plan identifies upgrades to help meet the needs of modern RV and tent campers. Many of the items were completed during the 2013 construction season; however, upgrades to the bathroom buildings, will require additional funding to complete. The aging restroom facilities are currently difficult to maintain and a challenge to keep in service.

Project Scope: Funds will be used to replace dilapidated and out of date restroom facilities.

Project Status: Since 2012, the department has upgraded campground facilities including the installation of Wi-Fi, electrical hook-ups to more campsites, and landscape and safety improvements. Additional funding will be used to construct new restroom facilities.

Need: Anchorage has over 250 miles of paved trails. Current infrastructure is outdated, unsafe and in need of repair. Trail use, both summer and winter, will continue to increase and safety and quality condition of trail infrastructure and amenities needs to be a priority.

Project Scope: Asphalt repair, lighting assessment and improvements, bridge repair/replacement, signage improvements

Project Status: Continuation of multi-year, multi-phase trail rehabilitation project including pavement resurfacing, drainage improvements, wayfinding, streambank restoration, and bridge replacement along the Campbell Creek Trail. Previously completed bond funded phases have rehabilitated trail from Dimond Blvd to Fairbanks Street. Future phases will continue east along the trail to Elmore Rd.

Project Scope: Design and construct an elevated bike/pedestrian bridge over Lake Otis Blvd to connect the east and west portions of the Campbell Creek Trail.

Project Status: A design alternatives study was completed in 2019 to evaluate potential options and rough order of magnitude costs estimates.
