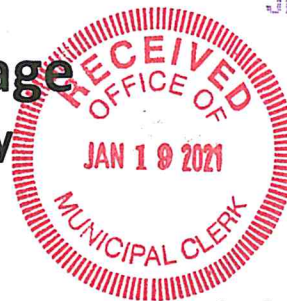
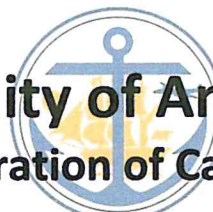


Municipality of Anchorage Declaration of Candidacy

I hereby declare my candidacy for CHUGIAK FIRE Service Area Board of Supervisors, Seat B. I agree to serve, if elected, for a 3-year term, expiring upon certification of the April 2024 Regular Municipal Election. I do hereby swear (affirm) that:

- (1) I am a resident of the Municipality of Anchorage; and I have been a resident of the service area designated above for 90 days immediately preceding the April 6, 2021 Election. (You are certifying that you have been a resident of the service area as of January 2, 2021.)
- (2) I am a qualified voter of the Municipality of Anchorage and the State of Alaska.
- (3) I meet all qualifications as set forth in AMC 28.30.020.

It is further understood that I may withdraw my declaration of candidacy by filing a statement under oath to the Municipal Clerk before 5:00 p.m. on February 2, 2021, in accordance with AMC 28.30.030D. I understand that if I file my request to withdraw after 5:00 p.m. on February 2, 2021, the Municipal Clerk has the sole discretion to remove my name from subsequent notices and the ballot.

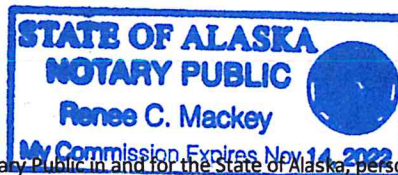
