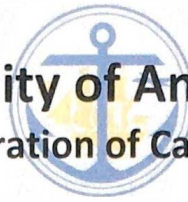


Municipality of Anchorage Declaration of Candidacy


- (1) I am a resident of the Municipality of Anchorage.

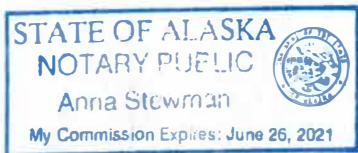
