- (3) I meet all qualifications as set forth in Anchorage Municipal Charter Section 6.02.

I understand that if I file my request to withdraw after 5:00 p.m. on February 2, 2021, the Municipal Clerk has the sole discretion to remove my name from subsequent notices and the ballot.

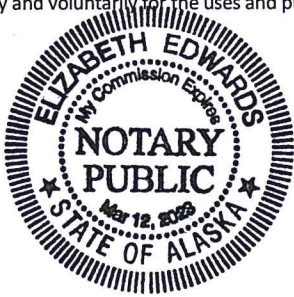
